New EU commitment for international biodiversity funding


The EU is doubling its external funds for biodiversity

7 billion euros will be spent to support African countries and other partners on biodiversity for the period 2021- 2027.

"Ahead of COP15 in December, we are confirming an unprecedented investment in support to our partners. I call on all international donors to match our ambition on biodiversity." President von der Leyen



NaturAfrica: an EU Flagship for people and nature

Key objective: support biodiversity conservation and socio-economic development in key landscapes/seascapes for conservation and development.

Beneficiaries: Six terrestrial biomes and 4 coastal/ocean windows, covering over 3 million km² that are home to 65 million inhabitants in around 35 countries


Total budget: around **1.5 billion EUR** in grant funding forecasted in NaturAfrica first phase (2021/2025).



The promotion of an integrated landscape approach



- An integrated approach to conservation and development objectives: linking conservation in protected areas with the development opportunities generated by the ecosystem services in surrounding areas
- Inclusive work with partner countries, regional and local authorities, local communities, national and local civil society, private sector, Member States, other EU partners
- Key enabling conditions: Security of land tenure and user rights, coordinated cross-sectoral planning and programming, inclusive governance, multi-sectoral monitoring






EU Support to the GGW

GREAT GREEN WALL

- Goal: regreen the Sahel from Senegal to Somalia through a mosaic of sustainable development projects.
- Key features: African-led movement and community-based
- 5 pillars: (i) sustainable agriculture; (ii) land restoration & sustainable ecosystem management; (iii) climate-resilient infrastructure & renewable energy; (iv) institutions & governance; (v) capacity building.
- One Planet Summit in 2021: EUR 700 million/year pledge
- Implementation: Support mainly via national programmes in 11+7 countries
- Official commitments for 2021: EUR 714.5 M
